TREE PLANTING OPPORTUNITY FOR CACAPON SOUTH LANDOWNERS

The Sleepy Creek Project Team has funding available for an Urban Tree Planting project in the fall of 2010. Because of the disastrous invasion of the Emerald Ash Borer and the killing of many of the large ash trees in the subdivision, Cacapon South subdivision has been selected as the site of the tree planting project. The funds are specified for an urban area, and a subdivision meets the qualifications. The Indian Run tributary which runs through Cacapon South also drains into Sleepy Creek above Oakland Road which makes it an important part of the watershed.

TESTING OUR WATERS A STREAM MONITORING WORKSHOP

Tim Craddock, Coordinator of WVDEP's Save Our Streams Program will present a hands-on workshop teaching the correct protocol for monitoring bacteria, including fecal coliform, in water.

This is not a certification workshop. However, participants will have a better understanding of bacteria monitoring procedures and can volunteer to help the Warm Springs Watershed Association gather baseline data. This method of testing can also be used in other streams.

Come prepared to get in the water to collect samples

Bring a bag lunch, hat, sunscreen, insect repellant, and waders, boots or shoes that can get wet.
